# Janet Weir Creighton



The Honorable Janet Weir Creighton was elected to the Board of Stark County Commissioners in 2010. As President of the Board, Commissioner Creighton brings the county more than 35 years of elected experience where she has cultivated a diverse background in government and public affairs.

Prior to returning to public service in Stark County, Janet was Deputy Assistant to The President of the United States

and Director of Intergovernmental Affairs from January 2008 until January 2009 in Washington, D.C. As the Director of Intergovernmental Affairs, she was the direct liaison between The President and officials in all cities, counties and states.

From 2004 - 2007, Janet served as the first female Mayor of the City of Canton. Prior to serving as Mayor, she was the Stark County Auditor (1991-2003) and Stark County Recorder (1985-1991).

Throughout her life, Janet has been selected to serve on many boards and commissions including a previous appointment to the Ohio Rail Commission, Public Director of the Federal Home Loan Bank Board for the 5th District, President of the Ohio County Auditors Association, Former Trustee of Malone University, and Chairman of the Board for Arts in Stark. In June, 2022 Creighton was elected Chairman of the Stark County Republican Party.

# Mary Ellen Withrow



Mary Ellen Withrow was confirmed unanimously by the Senate to be the 40th Treasurer of the United States on February 10 and sworn into office March 1, 1994.

She is the first person to have held the post of treasurer at all three levels of government- local, state and national. She was elected Treasurer of her native Marion County, Ohio in 1976 and 1980. She was elected as Ohio State Treasurer in 1982 and re-elected in 1986 and 1990.

As Treasurer of the United States, Withrow is responsible for the operations of both the U.S. Mint and the Bureau of Engraving and Printing. She is also the National Honorary Director of the U.S. Savings Bond program and in that capacity represents the Treasury Secretary nationwide to promote the sale of savings bonds.

During her tenure as Ohio's Treasurer, Withrow's innovative programs, management efficiencies and record earnings for Ohio earned her nationwide recognition. In March 1992, she received the Donald L. Scantlebury Memorial Award from the Treasury's Joint Financial Management Improvement Program for financial excellence and improvement in government.
